**DELTA COMMUNITY IMPROVEMENT PLAN(CIP) PUBLIC MEETING**

Brittany Mulhern, A/Manager of Development Services, reviewed the Staff Report provided at this meeting, stating that the Open House held on the previous evening at the Old Town Hall in Delta was well attended with positive comments received on the CIP process to date.

The Delta CIP Project Area, which identifies all properties proposed to be included in the project, was provided as an addendum to the Staff Report. The Project Area was identified as a result of public input received.

Mr. Cowley provided comments, stating that the CIP process creates an environment to attract businesses. He stated further that the Delta Community Improvement Plan Committee is grateful for the Township support in the vision for Delta, and that the Committee is eager to partner with the Township of Rideau Lakes to restore the heritage value of the village of Delta.
